# **2025 WASHINGTON STEM LEGISLATIVE PRIORITIES**

Early Care and Education: Maintain investments in early care and education and; increase capacity for child care by providing additional funding to the Early Learning Facilities Fund. (HB 1314/ SB 5297 for Early Learning Facilities)

P-12 STEM: Advance a shared vision and coordinated model across the P20 education system to support Washington students graduating STEM-literate and prepared for future careers by addressing persistent barriers in career and technical education (CTE) dual credit. (2SHB 1273)

Pathways to Credentials and Careers: Maintain funding to the statewide education and employer network, Career Connect Washington, to build and sustain access to equitable career connected learning programs that increase postsecondary enrollment and boost credential attainment. (Updated One Pager)

Data: Support modernization of P20W data systems to develop enhanced data resources and services to support legislative decision-making, state agencies, education providers, and community organizations serving students.(Updated HS Graduate Outcomes from ERDC)

# **PRIORITY UPDATES:**

**UPDATE:** 2SHB 1273: Improving student access to dual credit programs. Sponsored by Rep. Paul (10<sup>th</sup> LD)

- 2SHB 1273 was passed UNANIMOUSLY from the Senate Floor Friday afternoon. It now moves to the Governor for signature.
- Thank you to everyone throughout the process for support, testimony, sign ins and more.

# **Updates from Career Connect Washington (CCW) - Proposed Budget Impacts:**

- As budget writers continue to negotiate, we are working to preserve as much of the funding as possible and sustain critical components through Career Connect Washington (CCW) and prevent loss of progress for students and employers. The House funding proposal for CCL includes more for the critical components.
- Critical components we are highlighting:

- Grant Funds Scale What Works: Grants through the Employment Security
  Department to regional and sector partners ensure access to high-quality
  experiences statewide—exploration, preparation, and paid work.
- Coordinators Drive Regional Impact: Career Connected Learning Coordinators (CCLCs) in each of the nine educational service districts link K-12, higher education, and employers in their regions. They align programs into pathways that meet local employer needs. CCLCs catalyze new program creation through employer outreach and technical assistance to educators.
- Impacts of Proposed Budgets: Budgets are NOT final.

- We are grateful the legislature provided some funding. But we know these reductions will affect the program's success creating hands-on learning opportunities and career pathways for young adults across our state.
- Washington is a national leader in career connected learning (CCL) thanks to strategic investments in programs, policy, and infrastructure. Students want realworld learning—job shadows, internships, apprenticeships—and employers need skilled talent. CCL bridges this gap.

### **Early Care and Education:**

- <u>HB 1314</u>: Concerning the early learning facilities grant and loan program.
  - Passed unanimously from the Senate floor and was signed by Governor Ferguson on Monday.
- **Budget:** Check out <u>Start Early WA's budget analysis</u> for a comprehensive side-by-side of the House and Senate proposals across all things early care and education.

# **Updates from Olympia:**

- Fiscal cutoff on April 8, now moving into long days and nights of floor action. Bills must be voted from the floor by April 16. Both House and Senate will be working on Saturday.
- Conference committee (House and Senate budget leaders) are working now on a final budget proposal. Budgets must be released at least 24 hours before a vote.
- House and Senate Democratic leadership shared in their press conference this week they are working on revised/modified revenue proposals. Those may be released next week.

<u>Washington STEM 2025-2028 Strategic Plan: Keystones and Barriers:</u> Keystones are central principles or parts of a system on which all other parts of the system rely to thrive, often applied to architectural and ecological systems. We adopted this term to outline our long-term vision for the education system and to identify the key elements for its success. In addition to keystones, we have also recognized the barriers that Washington STEM is uniquely positioned to have influence to ensure the keystones of our education system serve all students.

- Keystone #1: All learners have equitable access to high quality early care and education.
  - Barrier 1: Lack of useful, population-specific data to guide decision making.
  - Barrier 2: Data capacity & use: when data is accessible, state and local leaders need support to use it for making changes in ECE policies, practices, and procedures.

- Keystone #2: All learners graduate STEM literate, with the knowledge, skills, and sense of belonging to thrive in their chosen career path and to solve local and global problems.
  - Barrier: Lack of cohesive approach and coordinated action towards STEM literacy.
- Keystone #3: All learners have access to multiple, equitable and accessible pathways to credentials and careers; and all learners are supported as they bridge the high school to postsecondary transition.
  - Barrier 1: Lack of cohesive pathways: Many institutions of higher education lack cohesive pathways from credentials to careers.
  - Barrier 2: Lack of cohesive career readiness approach: Our state lacks a cohesive approach to supporting students' postsecondary aspirations & transitions.
